- If you live and work in the U.S. and are a legal permanent resident of the U.S., you must provide a **valid Legal Permanent Resident Card, also known as a "Green Card" or "Alien Resident Card (ARC)"**

**Photocopies of any of the above documents are not acceptable.**

### Required Documents for Citizens of All Other Countries

In addition to a valid passport, many countries require an entry visa based on your nationality. It is each Guest's responsibility to identify and obtain all the necessary visas before commencing the cruise. Because requirements may vary, Guests are advised to contact their travel agent, government agency, embassy or consulate for more information on required travel documentation for the port of embarkation and all ports of call during the cruise.

If your country participates in the Visa Waiver Program, you are now required to have a valid machine-readable passport and obtain 72-hour advance travel authorization via the Electronic System for Travel Authorization (ESTA) prior to boarding carriers by air or sea to the U.S. under the Visa Waiver Program. For a list of applicable countries and registration requirements, ESTA information is accessible online at <http://cbp.gov/travel>. A copy of the approved ETSA application should be brought with you when traveling.

Passports are required to re-enter the U.S. via air.

### Packing for a Caribbean Cruise

#### What to Pack for a Disney Cruise to the Caribbean

It's your vacation! So dress comfortably aboard your Disney cruise, but be sure to bring the appropriate attire for onboard activities and dinner, plus any Port Adventures that you decide to do, as well as when you go into port. Here are our packing suggestions.

#### The Basics

Pack these items in a day bag to keep with you, as your luggage may not arrive at your stateroom until a few hours after boarding:

- Medications (in their original containers)
- Passport and travel documentation
- Camera and accessories (batteries, memory cards, etc.)
- Extra prescription glasses or contact lenses
- Swimsuit
- Sunscreen or hat
- Reading material

#### Attire and Accessories

- Beach cover-up
- Denim jeans
- Dinner attire (see below)
- Extra swimsuit
- Lightweight pants
- Long skirt (required for entry into some religious venues)
- Swim diapers for baby
- Sunglasses
- T-shirts
- Shorts
- Sundresses
- Sandals or sneakers (rubber-soled shoes for Port Adventures)
- Socks
- Wind jacket

In winter, you may also want to bring:

- Rain jacket
- Sweater or other layering pieces
- Closed-toe footwear

Dinner attire is "cruise casual," meaning no shorts, swimwear or tank tops. Diners at Palo or Remy, the adults-only restaurant, will want to dress more formally than when dining at our other restaurants. The Disney Cruise Line newsletter, Personal Navigator, will be delivered daily to your stateroom with attire advice for each night's dinner.

#### What Not To Pack

Everyone onboard a Disney cruise must comply with specific safety guidelines mandated by U.S. Customs and Port Security. This includes not packing certain items.

Please DO NOT bring:

- Firearms and ammunition, any kind of knives, swords, daggers, bullwhips or any other types of weapons are not allowed on the ship under any circumstances. If you arrive with such items, you must surrender them to Port Security for

the duration of your cruise and you can retrieve them when you return to port.

- Homemade, precooked or other perishable items
- Irons, bottle warmers, sporting equipment, balloons, candles, musical instruments, illegal drugs inclusive of medically prescribed and synthetic marijuana
- Coolers, except for those carrying medications, baby food or items related to dietary constraints



## OTHER "NEED TO KNOWS"

### Refusal Of Passage

Here's something really important to know before you make it all the way to Port Canaveral: Women who have entered their 24th week of pregnancy as of their embarkation date will be refused passage due to safety concerns. Likewise, infants under 12 weeks old will not be allowed to travel aboard Disney Cruise Line® ships.

### Cash/Credit Cards

In each port of call, you'll want to have some money with you for taxis, tips and whatever else may come up. In The Bahamas and the Caribbean, U.S. dollars and major credit cards (Visa, MasterCard, American Express, Discover Card, Diners Club, Japanese Credit Bureau or Disney's Visa Credit Card) are widely accepted. On the ship, you'll enjoy a "cash-free" life - as you must charge all onboard purchases (from drinks and spa charges to medical and laundry services) to your room via your Key to the World Card. All transactions and prices are in U.S. dollars. All charges must be settled before debarkation from the ship by cash, traveler's check, Disney Dollars or by the credit cards mentioned above.

### Gratuities

It's customary to give gratuities in recognition of good service, which we hope you will enjoy in abundance throughout your cruise.

For bar purchases - For your convenience while onboard, a 15% gratuity is automatically added to all bar, beverage, wine and deck-service tabs.

For Stateroom Hosts/Hostesses and Dining Team - On the day before returning to port, you'll be provided with the necessary forms and envelopes for presenting gratuities to your dining room and stateroom staff who have extended excellent service. You may use cash or charge gratuities to your stateroom account at Guest Services at any time during your cruise. You can also prepay your shipboard gratuities even before you sail by calling Reservations at 800-951-3532.

### Safety

"Safety first." It's our number one priority! Magic is a close second... but we have to be safe to make the

magic happen.

Safety drill - All hands (and Guests) on deck! Before sailing, everyone on board must participate in a safety drill. It lets you know what to do and where to go in case of an emergency. Just ask your Stateroom Host/Hostess or look on the back of your stateroom door to find out where to go for the drill.

### Smoking/Nonsmoking Policy

Most of the ship and ALL of the staterooms are nonsmoking, although smoking is permitted on stateroom verandahs and from 6 p.m. to 6 a.m. on the outside Deck 4 starboard side. Additional information is available on board. We ask that smokers please be considerate of nonsmokers, especially on your verandah.

### Health Center

Here's hoping you never have to use it. But if you do, the Health Center is open daily to assist with any medical emergencies or health concerns which may arise. Physicians and nurses are available after hours (even when we're in port) for conditions requiring immediate treatment. The physicians and nurses are not employees or representatives of Disney Cruise Line® and will charge their prevailing fees for services provided upon your request.

### Laundry Service

Self service - There are self-service Guest Laundry Rooms with washers, dryers and detergent available for a nominal fee (you can use your Key to the World Card to pay). Complimentary ironing equipment is available here, too. Please note that for safety reasons, irons and steamers may only be used in the Guest Laundry Rooms.

Full service - To have your clothing laundered or dry cleaned for an additional charge, just place it in the laundry bag provided in your stateroom, complete the accompanying form and your stateroom Host/Hostess will take care of the rest! Express Service is available
